- Dropping off your items **must be received by the Lead on shift** - *They cannot be left unattended*

Conditions of hire

To hire for a weekend period:

- There is a security bond of \$50 per item hired or \$60 for the pack. This bond will be refunded in full if all these conditions are adhered to and the Mini Golf is returned in the same condition it was borrowed Bond will be returned via bank transfer within 7-14 days after items are returned and checked. There is a \$50 cleaning fee if the Mini Golf is returned excessively dirty.
- Hire fee is not refundable if you decide to cancel your booking without adequate notice being 7 business days' notice.
- If toy/s are not returned within the time frame specified an overdue fee of \$30.00 will be charged.
- Please ensure that the mini golf is blown up fully and on a soft level surface. Check the ground where the mini golf will be set up for any sharp objects or debris. **IMPORTANT** - Do not install the mini golf over concrete or any hard surface. Ground stakes are provided for lawn ground surfaces. Stakes must be positioned level with or under the ground to prevent tripping hazard.
- Under no circumstances is water or any liquid to be used on the mini golf
- No shoes to be worn while on mini golf.
- No food or drink on the mini golf.
- After use, remove any dirt or marks with a damp cloth and allow to dry, please disinfect. Handheld vacuums and a dustpan and brush can be used to clean dirt off. Do not use excess water. Items returned not in a dry and clean state will incur a cleaning fee of \$50.00
- Ensure mini golf is fully dry and clean before packing away.
- Where supplied, you must read the Instruction Manual before setting up
- Once you have hired the item you have an hour to report any damage or issues before it becomes your responsibility (please inspect as soon as possible).
- Any damage or lost items that occur during your hire is your responsibility; and if so, please act immediately and report the damage to the Toy Library via Facebook message. This damage will need to be fixed by you and if it is unfixable then the item will need to be replaced at your own expense.
